Wang Mingxuan, member of the Party Leadership Group and Deputy Director of the Fujian Provincial Department of Housing and Urban-Rural Development, pointed out that property service companies are an important tool for social governance. At the same time, property service companies should further innovate the path of grassroots governance, focus on governance bottlenecks and difficulties, be a good "steward" and "nanny", and truly focus on the interests of owners, grasp party building leadership, team building, resource co-construction, and consultation and co-governance, open up simple and efficient channels to promote social governance, do their best to do a good job, serve owners with heart and soul, and help grassroots governance.

Director Hong Shijian stressed the need to continue to play the role of bridge and link of the contact point of the members of the Fujian Provincial Committee of the Chinese People's Political Consultative Conference, find the combination of what the Party and the government need, what the masses expect, and what the CPPCC can do, focus on the starting point of reform measures, and help improve people's livelihood and welfare with the effectiveness of the democratic supervision of the CPPCC. The contact points for provincial CPPCC members must always firmly adhere to the fundamental political position of "the CPPCC serves the people", participate in and supervise the entire process of solutions, responsibilities, policy guidance and task lists for relevant issues, so as to achieve the same direction of CPPCC democratic

supervision and the work of functional departments, and make CPPCC contributions to building a harmonious society.
